
St Tammany Parish Council Candidate Responses on Library Censorship

The following report is a compilation of library-related responses by St Tammany Parish Council Candidates that was compiled by the St Tammany Library Alliance in September of 2023 to help educate voters on the serious issue regarding censorship in our public libraries. This information is based upon 3 recently published publicly available surveys, with a supplemental set of questions only asked of District 1 candidates. I would proceed to get all the facts. The Board of Library Control is in place to govern the affairs of our Parish Library according to the applicable statutes and laws, its own bylaws, as well as the duties assigned by resolutions or ordinances of the St. Tammany Parish Council. I do not support the banning of books. I would, however, ask that the material deemed unsuitable for young children be placed in a location that is only accessible by adults. As a Parish Council member, we have the ability to appoint to the Library Board of Control. I believe only age appropriate books should be available to children. If the book is inappropriate then it should not be available. St Tammany Library system has a robust process in place to protect children but it is also important for parents to monitor their children. If a parent objects to a book then the parent should say no to the child. If the content is truly questionable then the parent should complete the paperwork to have the book reviewed by librarians.

I believe age appropriate books should be available to children. If the book is inappropriate then it should not be available. St Tammany Library system has a robust process in place to protect children but it is also important for parents to monitor their children. If a parent objects to a book then the parent should say no to the child. If the content is truly questionable then the parent should complete the paperwork to have the book reviewed by librarians.

3. Do you believe it is a parent's responsibility to monitor their child while visiting a public library?

Overall monitoring of children is the parent's responsibility. However, it is reasonable for a parent to expect age appropriate books to be the only books available in the children's section of the library.

While I believe librarians should make collection decisions, I also believe there should be a legitimate way for a parent to raise concerns if a book appears to be inappropriate. There should not be inappropriate reading material available to children. There needs to be a clear standard as to what is considered appropriate for different age levels.

While I agree that each parent should make the decision for their children, I also believe there should be a standard for what content is considered age appropriate. One parent may have a different view of what is age appropriate so having a common understanding is important. For

books that don't meet the standard, a parent could access the book of behalf of their child. Straight out banning books is not generally beneficial to society as a whole. It should go without saying that anything classified as pornography should NEVER be found in the library but it is also important to understand many adult books contain sexually explicit content that may be appropriate in the book's context and for an adult reader. Cherry picking sections of adult books and calling them pornography doesn't benefit society as a whole.

Decision making should be at the community level. A library should reflect the community they serve.

- 8. If elected, how would you ensure that readers will have access to a variety of books available to them and that the public has access to a variety of perspectives?
 - St. Tammany Parish Library System is among the best in our state. I met with the library director and have great confidence in her abilities. Our library has established a system that should give every parent confidence that age appropriate material is only available to children. Additionally, if a parent wants a book that isn't available on the shelf then the librarians can access the book for the parent. The library has several defense mechanisms in place to prevent a child from accessing inappropriate material.
- 9. Are there any books you would like to see censored or removed from public libraries in your community? Be as specific as possible.

Books of a sexual nature should not be available to children. If a parent wants such a book for their child then the parent should access the book. Pornography should not be available in the library. However, it's important to remember a book is not necessarily pornography just because it has adult sexual content in the context of a story. Such books should only be available in the adult section.

It is often stated that young people do not reach full mental development until they reach an age of approximately 25 years old. That's a fundamental understanding that we should keep more in the forefront of discussions such as this. I'm 72 years old, and I can say without any uncertainty that more than half of the most critical errors I have ever made in my life, I made before I was 25 years old; and some of those have resulted in unfortunate impacts which are still with me today.

I don't know how to establish the kind of standards governing access to books which I would like to see in place, because I have not researched this matter with the required thoroughness. As a general rule, I believe there should be access standards in place, however I am not prepared to define them here. I would have to study and assess the effectiveness of any precedents which are now in place or are planned for in the near future.

After further research, I understand that the American Library Association supports values which are not well aligned with the beliefs of the vast majority of the citizens of St. Tammany Parish. Indeed, the American Library Association has apparently given advice to Ms. Kelly LaRocca regarding the means and methods to circumvent recently enacted State of Louisiana laws regarding the restriction of certain books to age appropriate readers.

I believe the American Library Association is contributing to the obstruction of State of Louisiana, Governor-signed legislation.

That being the case, I cannot support the continuation of this relationship, and I suggest the State of Louisiana and St. Tammany Parish withdraw, separate or dissolve any continuing relationship or membership with the American Library Association immediately. Where the American Library Association promotes the circumvention of State Law, there exist grounds for charges ranging from obstruction to outright illegal behavior at the State level. Ms. LaRocca should be relieved of her position for ignoring and countermanding State Law.

I have been leading on the library issue in our parish since last October. This is one reason I have regularly been interviewed and discussed in the Slidell Independent and other media. Myself and some colleagues were largely responsible for pushing the library crisis to the forefront, resulting in the November RPEC forum in Slidell where the Attorney General spoke, which ended up being the largest public meeting in Slidell history. This was followed by a bill the Attorney General's office wrote which eventually became Act 436, which offers some protections for children in our library system. In addition, as our parish council kept telling the public that they couldn't do anything about the library situation, I worked with the Attorney General's office to draft HB25, which would have given them authority similar to what Jefferson parish has, ensuring our elected leaders had adequate oversight of the \$12 million per year taxpayers provide to our library system.

It's important to note that the New Orleans media refused to show pictures from many of the challenged materials because they were so sexually explicit, and Facebook took down examples that were being posted from the challenged materials because they said they violated their community standards.

If elected, I would ensure that our library system adequately reflected and respected community standards instead of challenging them, work to end the inappropriate relationship between our library system and the Chicago-based American Library Association, and remove library board members that refused to respect community standards, advocate unconstitutional positions like viewpoint discrimination and refused to enforce their own resolutions. In addition, I would work with our state delegation to enact some form of the bill I wrote, HB25, to give elected oversight to the parish council over our \$12 million annual library tax.

The parish council is ultimately responsible for our library board of control. They appointed them, and our Attorney General has said they can remove them, as Livingston Parish has done. It was shocking to us that after months of this controversy, in June, our parish council voted in two far-left ideologues instead of the other two candidates that adequately represented the community. Despite how disappointing this was, it just served as a reminder that our current parish council has failed to do its job and needs to be replaced.
